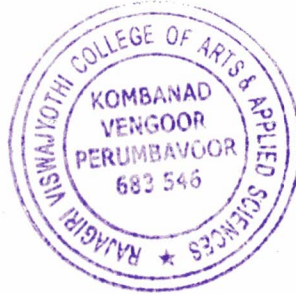

  - ii. In the case of the Income and Expenditure Account of the Excess of Income over Expenditure for the year ended on that date.

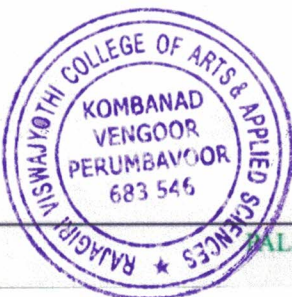
